





PLEASE READ INSTRUCTIONS BEFORE BEGINNING INSTALLATION

NOTE: Before starting installation, Park you Jeep on flat, level area, put in park and set emergency brake.

- Step 1 Using the 18mm socket with ratchet, remove the stock transfer case and transmission skid plates if equipped. Do this by removing the seven (7) bolts that attach the skids to frame and stock crossmember. Also remove the two (2) bolts that connect the gas tank skid to the crossmember (See Figure 1 Arrows to each bolt location)
- Step 2 Once the two skid plates are removed use the 16mm socket and ratchet to remove the three (3) nuts that secure the transmission mount to the crossmember. (See Figure 2)
- Step 3 Using the floor jack lift at the transfer case just enough to releive weight off of the transmission and crossmember.
- Step 4 Using the 18mm socket/ratchet and 18mm wrench, remove the four nuts on each side that connect the transmission crossmember to the frame mounts. (See Figure 3 on page 3)
- Step 5 With the weight of the transmission still releived from the crossmember, you can now remove the four long bolts holding the transmission crossmember in place. Remove the driver side first, then passenger side. You should be able to wiggle the passenger side out from between the gas tank skid and frame mount.
- Step 6 Install the Hyline HD Crossmember into place by first sliding the passenger side into place. Ensure the transmission mounting bolts are aligned and protrude through the holes in the HD Crossmember. Once in place, reinstall the long bolts and nuts you previously removed in step 5. DO NOT TIGHTEN YET






- Step 7 Now reinstall the long bolts and nuts on driver side.

 DO NOT TIGHTEN YET
- Step 8 Lower the jack from the transfer case and let the weight of the transmission rest on the HD Crossmember.

 Reposition the jack under the HD Crossmember and lift just enough until the vehicle itself begins to lift. This step will provide slighly more ground clearance and will take out any play within the large clearance holes on the factory transmission mounting brackets.
- Step 9 With the HD Crossmember lifted in place you can now tighten the long bolts and nuts to about 90 ft-lbs. Lower the jack and remove.



- Step 10 Reinstall the (3) three transmission mount nuts located on the bottom side of the HD Crossmember. Tighten the nuts at this time.
- Step 11 Using all the factory hardware, reinstall all of the skid plates you previously removed in Step 1.
- Step 12 2007-2011 models will require minor trimming of the factory transfer case skid plate if you're reinstalling that. Trim the one front flange that interferes with the HD Cross Member. 2012 and new models will NOT require any modification to the factory skids.

CLAIMS PROCEDURE Submit Warranty claim in writing, by certified mail to Hyline Offroad, LLC, 1507 C West Park Avenue, Perkasie, PA 18944. The Claim Notice must state the date of this Notice, the nature of the defect, date of purchase and if already installed, the date of installed the name of installer and include Proof of Purchase.

This Warranty shall be for the benefit of the original owner only, and is non-transferable. This Warranty is valid in those states where permitted. Some states do not allow limitations on the length of an implied warranty, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
